Good Afternoon Mr. Geragosian and Mr. Miner,

Please find attached a memorandum responsive to Yvonne Addo's memorandum of November 6, 2025.

While the \$230,000 in question may be small by State spending standards, it is the tip of a significantly larger iceberg. Since 2020, OPM has dispersed over \$153 million in the Local Capital Improvement Program known as LoCIP.

It appears that OPM may be misinterpreting CGS § 7-536(i) to nullify important portions of that statute that this provision is not intended to eliminate.

If the case in question is not isolated, this misinterpretation could invite widespread misallocation, abuse, and

maladministration.

The attached memorandum responds directly to OPM's interpretation of Conn. Gen. Stat. § 7-536(i), as stated by Yvonne Addo.
